FREE ERNST ZUNDEL

Ernst Zundel, 64, is a German-born publisher now going into his second year of imprisonment in a Canadian jail. He's held in Toronto's Metro West Detention Centre.

He's not charged with any crime, but has been held in "segregation" -- that's solitary confinement -- since February 19, 2003.

He's not charged with any crime, but is being held on a Canadian Security and Intelligence Service (CSIS) national security certificate. Canada's political police allege that he's a "terrorist".

This is a lie.

Mr. Zundel was born a Seventh Day Adventist. He chose Canada in 1958 because it did not draft young men into the armed forces. All his life he's preached non-violence. He's an ideas man, a graphic artist, a communicator. He's a landed immigrant in Canada and lived here from 1958 to 2000.

We know through Access to Information requests that Mr. Zundel was under police surveillance for his political views as early as 1960 -- for attending an anti-communist meeting! In 1995, according to Andrew Mitrovica's book COVERT ENTRY, CSIS was opening Mr. Zundel's mail.

In May of that year, they warned their mail opening snoop not to touch any package mailed to Mr. Zundel from Vancouver. Apparently, they knew a lethal pipe bomb had been sent to him by two anarchists.

CSIS did not warn Mr. Zundel or postal authorities. When the bomb arrived, Mr. Zundel was suspicious of the parcel, turned it over to the Metro Toronto Police, who detonated it and said it would have killed anyone within 100 yards.

CSIS are liars and have a political grudge against Mr. Zundel.

He came to Canada as a graphic artist. He employed many Canadians in his business. How did he so manage to antagonize powerful forces in Ottawa?

In the 1970s, he was outraged at the German-bashing in the mass media and the endless campaign against Germans and Ukrainians on the part of the "never-again" vengeance lobby. He tried to set the record straight and present the German point of view about World War II.

For his efforts, Zundel was massively punished by a nation that claims to believe in freedom of speech. In 1981-1982, his mailing privileges were taken away. He was twice charged under Canada's archaic "false news" law.

In 1992, the Supreme Court of Canada exonerated him and ruled the law unconstitutional. A prominent Jewish activist Sabina Citron then laid a Canadian Human Rights Commission complaint in 1996 to try to shut down the Zundelsite.

It's important to note that, despite long police surveillance, Ernst Zundel was never charged, much less convicted, for any crime or act of violence in Canada.

Mr. Zundel moved to the U.S. in 2000, but as part of that country's current mystery was deported to Canada in February, 2003. Under Canada's Immigration and Refugee Protection Act, the rarely used CSIS "national security" certificate becomes a deportation order that cannot be appealed immediately that a federal judge finds it "reasonable."

Note that the judge doesn't have to find that Mr. Zundel is a terrorist, but only that it's not unreasonable to think that he might be.

This hearing is currently going on in Toronto in front of a former CSIS boss and Solicitor-General Mr. Justice Pierre Blais. He's refused to reclude himself despite what seems to be a more than reasonable apprehension of bias. He was, after all, the former boss and confidant of the very security forces whose report he's now assessing.

He's allowed to accept "anything" -- including hearsay -- as evidence. Worse, much of the evidence is presented at secret -- "in camera" hearings, where neither Mr. Zundel nor his lawyers know the identity of the witnesses or the evidence.

This totalitarian procedure completely violates the hard-won protections of Anglo-Saxon Common Law, where the accused must have the right to know the charges against him and be able to confront the evidence against him.

Some federal judges have expressed concern about these procedures.

Mr. Justice James Hugesson said recently: "We hate it. We hate hearing only one party. We hate having to decide what, if any, sensitive material can or should be conveyed to the other party. This is not a happy posture for a judge, and you are in fact looking at an unhappy camper when I tell you about this function.

With these national security affidavits, if they are successful in persuading the judge, they will never see the light of day. The fact that something improper has been said to the court may never be revealed."

Ernst Zundel is being kept in solitary confinement as a political prisoner to break his spirit.

He's not allowed a pen, hardcover books or alternative health medications necessary to his health. He was denied treatment for almost nine months for a severe periodontal condition.

Canadian soldiers in German POW camps in WW II were allowed Red Cross packages with cigarettes, chocolates, tea, soap, etc. You're not allowed to send any of these items to him.

All this suffering comes about for no other reason than that the corrupt Ottawa politician establishment does not believe in free speech and wants to silence Ernst Zundel.
